

## TERMS & CONDITIONS

- 1. The promoter is: FXhome Ltd company no. 04172812 whose registered office is at Suite 4, 27 St Giles Street, Norwich, Norfolk, UK, NR2 1JN.
- 2. The Inside the Box Video Competition is open to anyone except employees of FXhome Ltd and their close relatives and anyone otherwise connected with the organisation or judging of the competition. Entrants under the age of 16 must gain their parents permission before entering.
- 3. There is no entry fee and no purchase necessary to enter this competition. Purchases of software do not increase the entrant's chances of winning.
